I understand that this application form is intended for use in evaluating my qualifications for employment and the position for which being considered and that it is not in any context to be considered an offer of employment. I understand that any false information, misrepresentations or omissions on this application, other written materials, or as provided during my interview(s) may lead to the rejection of my application and if employed, be cause for discipline up to and including the termination of my employment at the time any false information or omissions are discovered and that Kla-Mo-Ya Casino retains the right to terminate my employment on these grounds.

I expressly authorize, without reservation, KMYC, its representatives, employees, or agents to contact and obtain information from all references (personal and professional), employers, public agencies, licensing authorities, consumer reporting bureaus, and educational institutions and to otherwise verify the accuracy of all information provided by me in this application, other submitted documentation, or job interview(s). I hereby waive any and all rights and claims I may have regarding the employer, its agents, employees, or representatives, for seeking, gathering and using truthful and non-defamatory information in a lawful manner, in the employment process and all other persons, corporations, or organizations for furnishing such information about me.

It is further agreed, that this "at will" relationship may not be changed by any implied oral or written agreement or by conduct, that no supervisor or representative of KMYC is authorized to make any assurances to the contrary unless such change is approved and acknowledged in writing by the Kla-Mo-Ya Board of Directors.

I understand that KMYC maintains a policy of equal opportunity employment with regard to race, color, religion, national origin, sex, age, genetics, known disability or veteran status and no question on this application is used for the purpose of limiting or eliminating any applicant from consideration for employment on any basis prohibited by applicable local, state or federal law and adheres to the Tribal Employment Ordinance. Reasonable accommodation will be made as appropriate to enable any employee or applicant for employment to safely and properly perform the job for which applying as requested. It is understood however, that Kla-Mo-Ya Casino as an enterprise of The Klamath Tribes does adhere to a policy of Indian Preference.

I understand that Kla-Mo-Ya Casino has adopted an Alcohol & Drug Free Policy applicable to all employees and candidates for employment. As such, I hereby agree and consent, as a condition of my employment, to submitting to a pre-employment Alcohol & Drug test as established by KMYC and further authorize release of any test results to KMYC by the testing agency. I further understand that my failure to appear for said test within the time period allotted, to test positive for any covered substance, to refuse to sign a consent form or submit for testing or fail to cooperate in any manner or to produce an unacceptable specimen within the designated time period, will be cause for the rescinding of my job offer and disqualify me from further consideration for any position for a period of 24-months conditioned upon providing evidence of having successfully completing an appropriate treatment program. I further agree and consent that if hired and throughout the term of my employment with KMYC to abide by KMYC alcohol & drug testing policies and procedures (including random and suspicion) and authorize release of any such test results to KMYC.

I further understand that KTGRC's findings may be shared with KMYC and may affect my eligibility for employment. I also understand that KTGRC utilizes surveillance equipment as part of its daily operations and that I may be video and/or audio taped while on property.
